Only registered broker agencies will have access to the Broker Portal, and all sales agents must be added before the launch to ensure Customer leads must be created through the Broker Portal. Please be informed that lead created by portal will remain secure and accessible only to your agency unless you choose to share them with IMKAN. IMKAN will not contact your customers directly.

Key Reminders

- Only registered agencies and their authorized agents can access the Broker Portal to create and manage customer leads.
- Agency must ensure to Create customer leads using accurate information before booking appointments. Incorrect lead details may block appointment booking.
- Only Agency Admins will receive access to the Appointment System on 27 July to book customer appointments for the 29 July launch day.
